Thank you for your letter to Ecology Director Jay Manning informing us of your product NovaCool UEF Fire Extinguishing Foam. Director Manning has asked that I respond to you.

Based on what you have reported in your letter to Director Manning, it appears that your product meets/exceeds EPA guidelines, and contains a mixture of anionic, nonionic and amphoteric surfactants which interact with water to help extinguish fires rather than rely on halogenated hydrocarbons or polymers that are designed to suppress the flame.

Since Ecology does not endorse or purchase fire extinguishing foam products, I am referring your letter to the following individuals and agencies:
